

Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to tinyhorsestudio.com and Tiny Horse Studio and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to Tiny Horse Studio include tinyhorsestudio.com. The Tiny Horse Studio website is a portfolio and e-commerce site. Collection of your Personal Information

In order to better provide you with products and services offered on our Site, Tiny Horse Studio may collect personally identifiable information, such as your:
